### Issues relating to social media

Effective communication between home and school is incredibly important to us and as such everyone in school tries extremely hard to be approachable and supportive at all times. We are very proud of the relationships we have

built and believe the strength of these have ensured our children receive the best possible all-round care and support.

However, we have been made aware of some less effective lines of communication outside of our control and as such I would like to politely signpost parents and carers to our Communication Policy and Code of Conduct for Parents and Carers which can be found on our website;

In this Policy it states:-

There may be unofficial online school groups managed by parents for parents, such as WhatsApp groups, and they can be a source of knowledge, support and advice. If you choose to engage with these groups, we ask that you do so positively. However, if you do use these social media spaces, we ask that you use common sense when discussing school life online. Please, think before you post.

We ask that social media, whether public or private, should not be used to voice complaints against the school, school staff, parents, or pupils. Instead, parents are advised to follow the Complaints Procedure as this is the established route to resolve them. Parents should reflect on how they would respond if they were subject to public scrutiny on social media. Once messages are posted, they are in the public domain and are not easily retracted. We take inappropriate use of social media by a parent to publicly humiliate or criticise another parent, pupil, or member of staff very seriously.'

As always, please do not hesitate to contact school if you ever have any concerns or require support in any way. Thank you as always for your support and understanding, it is much appreciated.

All that remains for me to say is I wish you all a wonderful and healthy break. We start back to school with our next 'Well-being' day on Monday 4<sup>th</sup> November where there will be a Diwali workshop which is kindly being funded by our Friends of School. (please bring PE kits to school).
