This template can be used for multiple purposes:

 It enables schools to effectively plan their use of the Primary PE and sport premium

 It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium

 It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make additional and sustainable improvements to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use

they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

Further develop regular activity of all pupils during and after the school day through the following:

-Maintain and enhance PE equipment and resources, including outdoor play equipment/resourc es, to increase opportunities for physical activity, particularly during break times.

-Continue to train and support sport/play leaders (purchase any additional equipment needed to support this).

-Continue to offer a wide range of clubs during and after school.

All children who will benefit from improved play equipment/resources.

-SN (PE coordinator) and NS (sports coach)- as they will continue to support year 6 pupils to lead lunch time activities/clubs.

-Year 6 pupils – as they will be leading clubs and activities.

 -KS1 and LKS2 pupils – as they will benefit from taking part in lunchtime clubs/activities. Key indicator 2: The engagement of all pupils in regular physical activity – the Chief Medical Officer guidelines recommend that all children and young people aged 5 to 18 engage in at least 60 minutes of physical activity per day, of which 30 minutes should be in school.

## Key achievements 2024-2025

This template will be completed at the end of the academic year and will showcase the key achievements schools have made with their Primary PE and sport premium spending.

-Developing teaching and assessment through Get Set 4 PE and specialist coaching	-Building on last year's progress in staff confidence, lessons are now delivered with greater consistency across classes. Teachers are beginning to use resources more effectively to adapt provision, which has resulted in improved pupil outcomes in terms of skill development, vocabulary use, and enthusiasm for PE.	- Next step is to embed assessment fully so that progress can be tracked systematically.
